

### Market Report: Venture stocks soar into the Trump storm

February 3, 2025

An overview of insider sentiment and market trends with daily updates of indicator readings and top-50 tables of companies with net insider buying or selling.



#### Overview

February 3, 2025 - In our January 20th report, we suggested that, with the INK Venture Indicator at 425%, there appeared to be a positive setup for the speculative end of the market. At 425%, there were 4.25 stocks with key insider buying for every one with key insider selling. Given the uncertainty surrounding the incoming Trump administration's policies, global geopolitical tensions, and a tight Federal Reserve, it was an out-of-consensus view. So far, Canada's junior market has delivered, with the S&P/TSX Venture rallying 4.3%, ahead of most major North American indices.

Insiders are signalling that the good times may just be getting started. The INK Venture Indicator has risen to 460% even as junior stocks have rallied. Typically, insiders will sell into rallies. When they do not, it can be a very bullish sign. Canada is currently going through a challenging period as the Trump Administration announces tariffs on Americans who buy Canadian goods. How Canada comes out of this period will depend a lot on how Canadian society responds.

If Canada pivots towards pro-growth policies and innovation, Canada's junior markets are positioned to benefit. There are already encouraging signs. On Saturday, BC Premier Dave Eby announced that the province would be accelerating a total of 10 mining and energy projects for development and pledged to address project delays in the province. He also vowed to make BC internationally competitive with the United States. This is music to the ears of the resource community and reinforces the bullish take insiders have recently had toward BC resource stocks. As recently as our January 30th in the Morning INK, we reported on insider buying in the Toogoggone mining district in North-central BC.

Insiders are not so upbeat in the Consumer Cyclicals area which perhaps is not surprising given the risk of a full-blown trade war with the United States. The INK Consumer Cyclicals Indicator has slipped below 60%, and we are downgrading it to overvalued.

The INK Canadian Insider Index is being weighed down by tariff uncertainty, falling 1.9% last week. The Index laggards last week were ADF Group (Mixed; DRX), down 13.8%, Aecon Group (Cloudy; ARE), down 11.4%, and Bird Construction (Mixed; BDT), down 9.5.%. The leaders were DREAM Unlimited (Mixed; DRM), up 8.5%, Aura Minerals (Mostly Sunny; ORA), up 4.5%, and Tenaz Energy (Mixed; TNZ), up 4.4%. The INK CIN Index is down 1.3% year-to-date.

Core investment themes

#1 Watching for winners and losers under a Trump tariff regime

We expect Donald Trump to make growing use of sanctions as a means to raise revenue for the US government. The shift will lead to winners and losers in the North American economy. We will be watching to see how insiders react as tariffs rise and seek to highlight those sectors and industries that look set to do relatively well in such an environment.

#2 Broad adoption of artificial intelligence

The broad adoption of artificial intelligence gained traction with the public release of ChatGPT in late 2022. Unless AI proponents can significantly reduce the amount of power needed to process AI computations, many utilities will need to rely on natural gas for base load power. Meanwhile, copper demand should also be supported as server farms and grids are built out to accommodate the growing demand for AI applications. Uranium could also be a long-term winner from AI adoption if nuclear reactors are built to meet growing power needs.

#3 Geo-economic transformation

The development of a BRICS global payment system could conceivably take market share away from the US dollar. While it remains to be seen if an alternative global payment system will be successful, gold's recent rally suggests that something is cooking. Based on the 2024 BRICS summit, we expect member countries to continue to develop alternatives to legacy payment systems. We believe progress will look more like an evolution of systems rather than sudden disruption. As work continues, BRICS countries will continue to rely on gold as a key reserve asset to support the acceptance of their currencies in cross-border trade. As global investors begin to believe that the recent rally in gold is sustainable due to structural demand from the BRICS block, gold miners' multiples should expand. We also remain mindful of the political risks surrounding gold where governments may seek to limit its value or the ability of its citizens to hold it.

INK CIN Index Rebalancing, the INK Edge Outlook and Disclosures

Four times a year we rank all the names in our INK CIN Index stock selection pool (about 800 TSX-listed names) using our rules-based INK Edge outlook process which looks at a stock's value, insider commitment, and price momentum. For existing Index constituents, they must rank in the top 30% of all stocks in order to stay. Those that fail to meet the threshold are replaced with the highest-ranking stocks not already in the index.
